9. 2025 Sponsors – Keeping the same “Tiers” and pricing as 2024?

  - b. Tier 2 - Field (\$350 /year) – “Field Name” – mesh banner, Internet, back of t-shirt
  - c. Tier 3 - Supporter (\$100 per year) listed on back of t-shirt
  - **Plan to stick with tiers as above. We need to max Tier 1 at 10 so we don’t end up needing to cut sponsors in the fall.**
  - **Sponsors need to have a cutoff date to respond by, so email needs to be sent soon.**
  - **Sponsors should have all paperwork completed prior to their sponsorship being accepted: contract, logo, and business bio to be used for advertising on FB page.**
  - **Will need to reach out to reach out to Tier 1 sponsors that only received ½ year (KettleDad, Bradenville United Methodist, Level One and J&J Sealing) and give them 1<sup>st</sup> choice.**
  - **Due to error with end of season shirt, OAKS Western Beauty was offered a discounted sponsorship price (\$350) for the full year. OR free registration for any of her children for both spring and fall. She has not provided her choice yet. She should also receive 1<sup>st</sup> choice.**
