 - a. u6 – 23, u9 – 31, u12 – 32, u18-9.
 - b. Six u18 kids are under 15 & 2 are 15. Have the option to join the u12 (u15 or 15u). I need to reach out to the u18 families to discuss.
 - c. 3 teams per division (9 total), so we have 4 extra team sponsors (13 total)
 - d. Coaches, we are good for u12(u15), u9 we have 5, searching for an additional coach or two, u6 we have 5 and are looking for 1 additional.

- 11. Michelle and I have been reaching out a few families (3-4) that have outstanding balances from the Spring season (volunteer or registration)
I also emailed out notifications to all families that haven't paid registration fees for this season and said to pay before the 1st practices. NO uniforms will be handed out to families that owe fees of any kind, including Spring fees.
Moving forward all fees need to be paid before uniform can be released
